## STUDENT START-UP AND INNOVATION POLICY (SSIP)

#### Introduction

Government of India has declared 2010-20 as the decade of innovation to unleash the creative potential of every Indian. The Government of India has also set up the "Atal Innovation Mission" and "Startup India, Stand-up India" mission to spearhead innovation movement across the nation. Youth of the country and the university system play a crucial role at every step to shape the innovation ecosystem. To build startup and innovation culture across universities is the key goal of Startup India action plan. AICTE, under the ambit of the HRD Ministry, Government of India, is launching its own Startup Policy catering to technical institutes across the country including the institutes in Gujarat. - Harnessing the creative potential of young students across universities and educational institutions is also necessary to generate an entrepreneurial model of inclusive development
- The Student Start-up & Innovation Policy hence aims at ensuring that the students across all educational institutes of Gujarat get a conductive environment to solve problems and create ideas and opportunities.
- Students convert ideas into opportunities, that later can be supported as start-ups through various existing institutional mechanisms.

## KEY OBJECTIVES OF SSIP

- 1. Developing Innovation & Pre-incubation Ecosystem Support (*IPIES*) for students
- 2. Creating environment for creativity
- 3. Build internal capacity of educational institutions and key components of the innovation ecosystem
- 4. Create pathways for mind to market by harnessing and handholding projects/research/innovation/ideas of students in Gujarat
- 5. Creating and facilitating sect oral and regional innovation efforts in state
- 6. Create a common platform to showcase, support and upscale innovations
- 7. Leverage public system initiatives at state and central level, academia, industries

In order to achieve the above objectives, the SSIP cell supports the applicant in the following way

- Interventions at institute level
- Interventions at academic level
- Prototyping support
- Patent support
- Activities, events, mentoring, common institute-level facility, etc.:

## **Selection Process**

Based on the merits of the case, the evaluation of the idea/business plan for incubation purposes will be selected through review process. The committee for the review of the idea/innovation is formed according to the guideline given by SSIP Govt of Gujarat. This may take a few iterations till desired clarity of the idea/business is achieved. External review- A business plan/deck is to be prepared after satisfactory internal review by the applicant. This is then sent to Institute Level SSIP Committee comprising of Industry Expert, Finance Expert, Academic Expert, Start-up eco expert and IPR Scrutiny Committee
